The special meeting was called to order at 7:00 p.m. on January 27, 2026 by Council President Andy Pinsky. After the Pledge of Allegiance and a moment of silence was observed, roll call was taken. Mrs. Stephanie Schropp, Mr. Andy Pinsky, Mr. Richie CLawson, Mrs. Charity Colebank, Mr. Jim Magda, Mrs. Mary Yeager, Mayor Lindy House, Mrs. Amy Baker and Mrs. Stacey Coffman were all in attendance. Solicitor Gary Falatovich joined the meeting via phone. Mr. Mickey Siwula and Mr. Steve Eby were not in attendance.

**F. Action Items**

- a. Auditor Report (Executive Session): The Executive Session was entered into at 7:05 and ended at 8:07. A 5 minute break was observed and the meeting continued.
- b. Civil Service:

- c. Lease Agreement For the Borough Building Space: Solicitor Gary Falatovich has approved the lease agreement for Mrs. Kelly Imel. A motion was by Mrs. Mary Yeager to all Mrs. Imel to lease the building space. The motion was seconded by Mr. Jim Magda, all in favor, no one opposed, motion carries.
- d. Revised Budget: After working on any concerns or questions Council had with the budget the corrections were made. A motion was made by Mrs. Emily Seaman to accept the revised 2026 Budget. The vote is unanimous, motion carries.
