

RESOLUTION NO. 2026-10

A RESOLUTION OF THE BOROUGH OF SCOTTTDALE, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA APPROVING AN AGREEMENT WITH GREENRIDGE WASTE SERVICES, LLC D/B/A REPUBLIC SERVICES OF SCOTTTDALE, FOR SOLID WASTE COLLECTION SERVICES WITHIN THE BOROUGH FROM JUNE 1, 2026 TO MAY 31, 2031

WHEREAS, the BOROUGH OF SCOTTTDALE (hereafter the "BOROUGH"), is a municipal corporation organized and existing under the laws of the Commonwealth of Pennsylvania, located in the County of Westmoreland and Commonwealth of Pennsylvania, and is authorized under the Pennsylvania Borough Code to regulate the collection, removal and disposal of garbage, ashes, rubbish, Christmas trees and other solid waste within the Borough; and

WHEREAS, the BOROUGH has enacted Ordinances, and incorporated same into the Code of Scottsdale Borough, providing for the award of contracts for the collection, removal and disposal of said garbage, ashes, rubbish, Christmas trees and other solid waste in compliance with the Borough Code; and

WHEREAS, pursuant to the terms and provisions of the Ordinances and Code, the Borough prepared specifications, and solicited bids, for the exclusive right to collect garbage, ashes, rubbish, Christmas trees and other solid waste within the geographical limits of said Borough and for disposal of the same; and

WHEREAS, the proposal of GREENRIDGE WASTE SERVICES, LLC D/B/A REPUBLIC SERVICES OF SCOTTTDALE (hereafter referred to as "CONTRACTOR") was accepted by the Borough at a public meeting held on the 9th Day of March, 2026 subject to the entry of a Contract with the Borough detailing and confirming the terms, conditions and provisions under which such services would be provided; and

WHEREAS, pursuant to the terms of Chapter 20 of the Code of Scottsdale Borough relating to the removal of Solid Waste, the Council of Scottsdale Borough desires to approve and adopt a Resolution approving those terms, conditions and provisions set forth in the Waste Services Agreement in the form attached hereto as Exhibit "A" and grant CONTRACTOR the exclusive right to collect garbage, ashes, rubbish, Christmas trees and other solid waste within the geographical limits of said Borough for a period commencing June 1, 2026 and ending May 31, 2031.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE COUNCIL OF THE BOROUGH OF SCOTTTDALE HEREBY RESOLVES AS FOLLOWS:


1. THAT, the Waste Services Agreement with CONTRACTOR in the form attached hereto as Exhibit "A", be and is hereby APPROVED; and

2. THAT, the President of Scottdale Borough Council and the Secretary of the Borough are hereby authorized to execute the attached Agreement on behalf of the Borough of Scottdale.
